



Health Equity Scholars for Action 2023 Application/Letter of Intent Deadline: May 31, 2023

The goal of Health Equity Scholars for Action (HES4A) is to enhance the supports, resources, and community necessary for participants with historically underrepresented backgrounds (HURs) to thrive professionally and personally. In turn, researchers will be better able to contribute to and expand health equity-related research and evidence that dismantle systemic and structural barriers to health and wellbeing.

Grants will be awarded to address the challenges that HURs typically experience and help them overcome obstacles to earning tenure. Studies funded through this 2023 call for proposals will need to be completed within a two-year time frame and those involving community centered/engaged approaches are welcome. Research may be conducted as standalone projects or as part of larger studies or trials already underway.

A total of 15 awards will be funded at up to \$260,000 each. The award duration is 24 months.

Applicants are encouraged to attend the webinar on May 10, 2023 (12-1 p.m. ET). Registration is required.

The National Institute on Aging (NIA) and NIH Office of AIDS Research (OAR) with participating NIH Institutes and Centers announce the availability of administrative supplements to support research on HIV/AIDS and aging. Eligible parent awards include existing projects funded by the participating Institutes and Centers listed above with or without an existing focus on HIV/AIDS as long as other eligibility criteria are met and are within scope of the original project. Supplemental projects may involve a variety of scientific approaches and methods provided that they are focused on HIV/AIDS, can be conducted within one year of the supplement award, address previously unforeseen research opportunities, and fit within the scope of the parent grant. Within scope means that the proposed aims do not add to or expand the existing study in a manner that would be more appropriate for a competing peer-reviewed mechanism and/or revision application.

Chan Zuckerberg Initiative % **RFA: Collaborative Pairs Pilot Project Awards**

Applications due June 22, 2023 by 5 p.m. Pacific Time

The Chan Zuckerberg Initiative (CZI) invites letters of intent for Cycle 2 of the Collaborative Pairs Pilot Project Awards to support pairs of investigators and their teams to explore innovative, interdisciplinary approaches to address critical challenges in the neurodegenerative disease field and in areas of fundamental neuroscience such as the cellular, molecular and circuit mechanisms of cognition & memory and the neuroscience of sleep. Awards are \$200,000 in total costs per collaborating pair for a period of 18 months, after which successful projects will be eligible to apply for additional four-year acceleration grants that build on pilot phase studies. Collaborative Pairs teams will benefit from the support, mentoring and collaborative interactions of the CZI Neurodegeneration Challenge Network, as well as interactions with the broader CZ Science programs and grantee network. Information Technology Be reminded that beginning June 1, 2023, GW will be instituting a **180-day deletion policy** for all cloud video recordings stored on GW provided platforms (Zoom, WebEx, Blackboard Collaborate, and Teams). Please note that this new policy does not pertain to 2U supported Zoom accounts. In view of this new policy, please give some thought to whether you have any academic or research related recordings that need to be preserved. Please visit the GW IT website for **more information on the 180 day storage limits**. This website includes instruction guides on how and where to move your recordings. For researchers and research teams that have been using these platforms to conduct human subject research (consent recordings, individual or group interviews e.t.c), this new policy provides an opportunity to ensure they are in compliance with IRB approved protocols, approved data management plans as well as sponsor expectations regarding storage of research data.

If you believe that you may have video recordings that need to be preserved beyond the 180-retention window and would like to request assistance backing up the records, please:

Complete this form so that your needs can be addressed and carefully review the policy and support information.

New GWIT Policy Regarding Cloud Recording:

Recordings after January 1, 2023, will be saved for 180 days. After 180 days, recordings will be moved to the meeting host's "Trash" folder for an additional 30 days. Once the 30-day Trash countdown expires, the recordings will be permanently deleted and cannot be recovered.

On June 30, 2023 all recordings that are older than 180 days will be moved to the meeting host's "Trash" folder for 30 days. Once the 30-day Trash countdown expires, the recordings will be permanently deleted and cannot be recovered.
