Research Project Highlight

Dr. Munar is the Director of the Gill-Lebovic Center for the Caribbean and Latin America and an Assistant Professor in the Department of Global Health at the GWSPH. Before joining the GW research community, he occupied leadership positions at various global



health, philanthropic, international development, and governmental organizations. Dr. Munar's research is focused on health systems research in low- and middle-income countries. In partnership with PATH, he was recently awarded a \$5 million 5-year grant from the Bill & Melinda Gates Foundation focused on the routine immunization programs in the Democratic Republic of Congo, Niger, Pakistan, and Somalia. A participatory Learning Consortium was established between GWU and PATH,

along with research centers and universities in participating countries. The award aims to characterize how routine immunization programs are operating, identify their effects, and explain why they are working or not. The learning acquired will be iteratively shared with implementers, decision-makers, and global stakeholders involved in routine immunization in the focus countries as well as in other conflict and postconflict countries in Africa, Asia, and the Eastern Mediterranean regions. We expect that participatory prioritization of learning questions, agenda setting, knowledge creation, and evidence dissemination will contribute to rapid cycles
