The Milken Institute School of Public Health (SPH) offers the Minor in Public Health. Through this minor, students are introduced to a wide range of public health topics, such as health epidemiology, health management, health policy, health behavior, environmental and occupational health, global health, and others. The Public Health Minor consists of at least 18 credits (9 credits of required public health courses and nine credits of public health elective courses). The minor provides a strong foundation in public health in preparation for professional schools including: law school, medical school, physician assistant school, allied health professional school, public health and health services school.

Admissions Requirements: 2.8 cumulative GPA or above, (and notification of seat available from waitlist).

To Add or Drop a Minor and to Change the Original Program of Study

Milken Institute SPH will not process requests to add a Minor in Public Health during the registration period. All transactions require the Application for Undergraduate Minor form and signatures. Note:

Only two groups of students are permitted to double-count courses toward their Minors in Public Health:

- Milken Institute SPH students with a major in Exercise Science or Nutrition Science may count PUBH 1101 Introduction to Public Health toward both programs.
- Elliott School of International Affairs students with a major in International Affairs and concentration in Global Public Health may count PUBH 3133 (Global Health & Development) toward both programs.

No other courses are eligible to be double-counted or shared between programs of study. If necessary, additional electives from the approved list may be used to substitute for required courses, but the student must petition the Program Director for any exceptions. Please see the Milken Institute SPH Undergraduate Advisor.
