Background

Minors across schools have been established within the University to provide opportunities for formal inter-school study. Students must be enrolled in a degree program and must be in good standing to be eligible to take a Minor in another school. The Minor generally consist of 15-21 credits of prescribed courses, depending on the Field. The Minor in Public Health requires 18 credits. Upon successful completion of all requirements, the title of Minor and the courses taken in support of the Field are entered on the student's transcript.

The Milken Institute School of Public Health (SPH) offers the Minor in Public Health. Through this minor, students are introduced to a wide range of issues in areas of public health such as health epidemiology, health management, health policy, health behavior, environmental and occupational health, global health, and others. The Public Health Minor consists of at least 18 credits (9 credits of required public health courses, and 9 credits of elective courses). The minor provides a strong foundation in public health in preparation for professional schools including: law school, medical school, physician assistant school, allied health professional school, public health and health services school.

Admissions Requirements: 2.8 cumulative GPA or above.

To Add or Drop a Minor and to Change the Original Program of Study

Please see the Undergraduate Advisor or Program Director for assistance in the selection of the elective course and to amend the courses on the original program of study. Milken Institute SPH will not process requests to add a Minor in Public Health immediately before or during the registration period. All transactions require the Application for Undergraduate Minor form and signatures. Submit to: Milken Institute SPH, Office of Student Affairs. **Because the minor has a limited capacity, students must reach out to the Undergraduate Advisor and be placed on a waitlist.**

Elliot School of International Affairs students with a major in International Affairs and concentration in Global Public Health may count PUBH 3133 (Global Health & Development) toward both programs. **Other courses will not be counted toward both programs.** If necessary, additional electives may be used to substitute for required courses.
